10) That if there is any breach of conditions as mentioned above, the permission will be revoked without any intimation.

11) RMC produced shall be given priority for supply to Government approved

project order as per requirement.

12) That the Guidelines for reduction of Air pollution issued by Chief Engineer (D.P.) BMC dt.15/09/2023 &Hon'ble Municipal Commissioner (BMC) dt. 25/10/2023 shall be strictly followed on site.
