- 4) That the NOC from A.A. & C., H/W Ward shall be submitted.
- 5) That the requisite Payment shall be made.
- 6) That "All Dues Clearance Certificate" related to H.E.'s dept. from the concerned A.E.W.W. [H/W Ward] shall be submitted before applying for C.C.
- 7) That the H.E, NOC shall be submitted before applying for C.C.
- 8) That the NOC from P.C.O Noc shall be submitted
- 9) That all the conditions and directions specified in the order of Hon'ble Supreme Court dated 15/03/2018 in Dumping Ground case shall be complied with before starting demolition of structures and/or starting any construction work.NOC from SWM shall be submitted.
- That adequate safeguards are employed in consultation with SWM Dept. of MCGM for preventing dispersal of particles through air and the construction debris generated shall be deposited in specific sites inspected and approved by MCGM.
