
#### **B: FOR LABOUR CAMP / TEMPORARY SHED**

- That N.O.C. from Civil Aviation department will not be obtained for the proposed height of the building.
- That the debris shall not be transported to the respective Municipal dumping site and challan to that effect shall not be submitted to this office for record.
- That the notice in the form of appendix XVI of D.C.R. shall not be submitted on completion of plinth.

#### C: CONDITIONS TO BE COMPILED BEFORE FURTHER C.C

- 1) All the Conditions of this office I.O.D. under even no. dated 28.12.2022 shall be applicable and should be complied with.
- 2) That the revised R.C.C. drawing/designs, calculations shall be submitted through Licensed Structural
- 3 3) That the Janata Insurance Policy or policy to cover the compensation claims arising out of workman's compensation Act 1923 will be taken out before starting the work and also will be renewed during the construction work
- 4 4) That the NOC from A.A. & C., H/E Ward shall be submitted
- 5 That the requisite Payment shall be made
- 6 6) That "All Dues Clearance Certificate" related to H.E.'s dept. from the concerned A.E.W.W. [H/E Ward] shall be submitted before applying for C.C
- 7 7) That the H.E, NOC shall be submitted before applying for C.C.
- 8 8) That the NOC from P.C.O Noc shall be submitted
- 9) That all the conditions and directions specified in the order of Hon'ble Supreme Court dated 15/03/2018 in Dumping Ground case shall be complied with before starting demolition of structures and/or starting any construction work. NOC from SWM shall be submitted

- That adequate safeguards are employed in consultation with SWM Dept. of MCGM for preventing dispersal of particles through air and the construction debris generated shall be deposited in specific sites inspected and approved by MCGM
- 11 That the debris shall be managed in accordance with the provisions of Construction and Demolition Waste Management Rules 2016 and requisite Bank Guarantee as demanded by MCGM/MHADA for faithful compliance of Waste/Debris Management plan shall be furnished before demolition of structures or construction work
- 12 Water work certificate of 270-A as per MMC act 1888 shall be submitted before of asking Occupation Certificate
- 13 That the provision for electric charging point for electric vehicle shall be provided at stilt floor before of asking Occupation Certificate
- 14 That the Solar Power generated system shall be provided before asking Occupation certificate
- That the all-precautionary measures shall be taken to control Environment pollution during the building construction activities as per circular issued by MHADA u/No ET-321 dated 25.10.2023 and Govt. of Maharashtra directives issued U/no CAP-2023/CR-170/TC dated 27.10. 2023.Necessary compliance shall be submitted before asking every approval and required by planning Cell/GM/MHADA

## SPECIAL INSTRUCTIONS

- 1. THIS INTIMATION GIVES NO RIGHT TO BUILD UPON GROUND WHICH IS NOT YOUR PROPERTY.
- 2. "Every person who shall erect as new domestic building shall cause the same to be built so that every part of the plinth shall be
  - a. Not less than, 2 feet (60 cms.) above the center of the adjoining street at the nearest point at which the drain from such building can be connected with the sewer than existing or thereafter to be-laid in such street.
  - b. Not less than 2 feet (60 cms.) Above every portion of the ground within 5 feet (160 cms.)-of such building.
  - c. Not less than 92 ft.( Town Hall) above Town Hall Datum.
- 3. Your attention is invited to the provision of Section 152 of the Act where by the person liable to pay property taxes is required to give notice of erection of a new building or occupation of building which has been vacant, to the Commissioner, within fifteen days of the completion or of the occupation whichever first occurs.
