- 2. That no new building or part thereof shall be occupied or allowed to be occupied or used or permitted to be used by any person until occupancy permission has been granted.
- 3. This permission does not entitle you to develop land which does not vest with you. If the work is not commenced immediately w.e.f. this Plinth C C issued date.
- 4. That the concern Airport authority NOC for subjected project shall be obtained before asking further C C & shall be submitted to this office.
- 5. The Balanced Labour cess of 1st installment of Rs.4,00,000/- & balanced Balcony Premium of Rs.69,410/- shall be paid before actual start of work. If not paid in stipulated time then the intrest as per norms shall be recovered from you before asking Further C C.

- 7. The conditions of this certificate shall be binding not only on the applicant but on his heirs, executors, assignees, administrators and successors and every person deriving title through or under him.
