Minutes of 2nd Meeting of SLAC

Date of Meeting: 7th and 8th December 2016 to be continued on 23.12.2016

The 2nd meeting of SLAC under the Chairmanship of Dy. Secretary, Housing, Govt. of Maharashtra was held on 07.12.2016 & 08.12.2016 at Meeting Hall of Shivshahi Punarvasan Prakalp Ltd., 5th Floor, Griha Nirman Bhavan, Kalanagar, Bandra(E), Mumbai 400 051.

- 2. The Chief Officer from Nashik and Aurangabad Housing & Area Development Board and Officers of Regional Boards and NIT except Nagpur Housing Board attended Meeting.
- 3. There were 25 DPR proposals were placed before the Committee, out of which 2 proposals were from Nagpur Improvement Trust (NIT) & 23 proposals were from MHADA as Implementing Agency (IA).
- 4. The Chief Engineer-II/MHADA & SLNO/PMAY has submitted Agenda Item Notes for the meeting vide letter no.MH/CE-II/Dy.CE/EE-I/PMAY/A/F.No./1337/16, date 03.12.2016. Only 21 DPRs in the Format 7B' of Agenda Item Notes were received without signature of SLNO/PMAY. The Format 7B' of Agenda Item Notes no.2/9, 2/10, 2/11, 2/12, 2/13, 2/15, 2/16, 2/17, 2/18, 2/19 & 2/20 were signed by the representative of MHADA as Implementing Agency. All other Format 7B' of Agenda Item Notes were unsinged by the MHADA as Implementing Agency. The Agenda Item Notes at sr.no.2/1 & 2/2 of Nagpur Improvement Trust were not received but placed before the Committee 'On Table'. The DPR proposal at 2/2 i.e. for 1024 EWS DUs has been modified by NIT to 960 EWS DUs.
- 5. The State Level Nodal Officer(SLNO)/MHADA has informed the Committee that; MHADA is withdrawing the 2 DPRs at 2/14 (Karanjc Tarfe, Satara) & 2/21(Vita, Sangali) being some local issues.
- 6. The presentation for remaining 23 DPR proposals as per the Agenda placed before the Committee; was made by the Implementing Agency.
- 7. During the presentation the Committee noticed that the DPRs were not at all scrutinized by SLNA/MHADA. Chairman, SLAC instructed SLNA/MHADA to scrutinize the proposal thoroughly as per the PMAY Guidelines and thereafter put up

the proposals for SLAC's appraisal. In future SLNA/MHADA should ensure that the DPR proposals received to SLNA from ULB/IA shall be placed before SLAC with their observation and recommendation.

Following are the observations made;

- 1) Coloured copy of DP Sheet was not enclosed with the proposal.
- ... 2) .. In some DPR proposals the readable google maps weternot enclosed.
 - 3) Two DPR proposal are abutting to Nalla/River, HFL is not marked on plan. It cannot be ensured whether proposal is getting affected or otherwise.
 - 4) The City Level Infrastructure (Water Supply, Sewerage, Electricity etc.) Plans showing the onsite connections of services, were not available.
 - 5) The final disposal point of effluent was not shown on layout wherever Septic Tank is proposed.
 - 6) The assurance of Water Supply from the Local Authority was not enclosed with the proposal.
 - 7) Some of the estimates of the proposals were framed on old DSR like 2012-13, 2014-15.
- In some of the proposals the estimates for all infrastructure works were not attached.
- 9) The specifications for finishes of the house were not uniform and there was variance in the provisions like Flooring, Door Shutters, Windows etc.
- 10) The onsite infrastructure estimates in some of the projects were not made correctly, like External Electrification, Sewerage System. Compound Wall etc.
- 11) The rates adopted for the estimates were considered as hilly area though the Mission City do not fall under Hilly Area. Also some ad-hoc percentage like 10% added for cushion and wastage etc.
- 12) While working the Sale Price of EWS house the percentage of "Others" with respect to building and infrastructure cost varies largely (20% to 50%).

- 13) The plans & estimates were not signed by the Technical Competent Authority of MHADA in token of estimates technically verified and are in order.
- 14) The DPR proposals do not include the information regarding 'Demand Assessment' of Urban Poor in the City as per PMAY Guidelines.
- 15) So far out of the projects sanctioned by CSMC and placed for approval of SLAC, 55 DPR proposals are of MHADA as Implementing Agency (3 DPRs withdrawn by MHADA out of CSMC approved proposals and 3 DPRs out of DPRs placed before 2nd SLAC). All the DPR proposals of MHADA are proposed to be executed: through MHADA funds as seen from the DPR. In view of this to complete the project smoothly year wise Cash Flow of the projects needs to be provided by MHADA along with source of fund.

In view of observations made by the Committee mentioned above; it is decided to get the compliances done and verified by SLNA/MHADA for all 22 projects on or before 19th December 2016. DPR wise observations are mentioned as below;
