

Minutes of the 23rd meeting of State Level Appraisal Committee (SLSMC) for PMAY-HFA (U) held on 21st November 2019

- 1. The 23rd meeting of SLSMC for PMAY-HFA (U) was held on 25th November,2019 at 01:00 pm, at Conference hall of Chief Secretary's office 6th floor, Mantralaya, Mumbai.
- 2. The Honorable Chief Secretary, Govt. of Maharashtra and Chairman, SLSMC Shri. Ajay Mehta presided over the meeting on 25th November 2019. The List of Participants is at **Annexure-I**.
- 3. The Member Secretary welcomed the Honorable Chief Secretary and all members present and briefed them about the agenda of the meeting.
- 4. The minutes are as follows.

Important Observations/Directions of SLSMC

- 1 There is a large gap in number of applications received on PMAY-MIS portal and validation thereof. All the ULBs are therefore directed to complete the validation of beneficiary on top priority and ensure that eligible applicants are included in the project proposals being submitted for approval.
- 2 ULBs to ensure completion of the entire project related entries in PMAY-MIS urgently.
- 3 ULBs/ Implementing agencies to also ensure completion of all entries in PMAY-MIS and beneficiary attachment before submitting any project proposals
- 4 The Implementing Agencies are directed to complete the MIS entries of beneficiaries including Aadhar seeding, before submission to CSMC.
- 5 ULBs/ Implementing Agencies to obtain all the approvals/ clearances/ Permissions/ NOCs etc. as required under prevailing statute for their proposals at their own level. ULBs/ Implementing agencies should also adhere to their regular process of approval as per prevailing statute
- 6 Hon'ble Chief Secretary, Government of Maharashtra emphasized on the need of early start of houses approved under PMAY (U).
- 7 Lead Chart/ Quarry Chart needs to be certified by Competent Authority.
- 8 ULB to ensure all the plots under the project are in developable zone.
- 9 ULB to ensure the plot area of the beneficiaries which has been considered in this DPR is developable as per Municipal council Building Bye-laws.
- 10 ULB to ensure that the Aadhar details of beneficiaries with regards to their number and name is accurate while updating in PMAY(U) MIS.
- 11 ULB to ensure that Carpet Area considered for the house should be as per the amendment made in guidelines of PMAY (U).



- 12 ULBs to ensure that all the documents attached with DPR are certified by competent authority of ULB.
- 13 ULB/Implementing Agency/ Developer to ensure the availability of proper road connectivity, Water supply and Power NOC from concerned authority, availability of Solid waste management etc. with the proposed project site.
- 14 In AHP / PPP Projects, demand risk shall be borne by the developer / Project proponent.
- 15 All the implementing Agencies are directed to ensure basic infrastructure such as access road, water supply, electricity is available to the project.
- 16 All other statutory permissions / NOCs like environmental clearance if needed be obtained by the project proponent / I.A.
- 17 The Project Proponent, implementing agency is solely responsible for ownership and development issues of land. Mere approval of DPR doesn't approve title of the land and other land and development issues. It is sole responsibility of the Project Proponent, implementing agency.
- 18 The Chairman SLSMC and Chief Secretary, Government of Maharashtra again reiterated Chairman, SLAC's directives that the ULB wise targets given are indicative and proposals beyond target should be solicited.
- 19 The Chairman SLSMC & Chief Secretary, GOM reiterated Chairman, SLAC's directives that for AHP-PPP projects the possibility of funds routed through RERA escrow account be explored and if it is possible then both State and Central share fund should be routed through RERA escrow account.

1.The DPR for Construction of 99 EWS and 4 LIG DUs is submitted by Mumbai Board. In the proposal the following observations needs clarity from Mumbai Board.: 1. There is no clarity regarding land ownership of the proposal, neither the land ownership is mentioned in the DPR scrutiny sheet by the Mumbai Board. This needs to be very clear as the relationship between the land owner and project proponent cannot be established in the present form. 2.

- 3. The DPR scrutiny checklist needs to be filled in properly. For example, 1.10 it must be Mumbai Board, MHADA and not MHADA/ M.B. 4. It is not clear as to how the proportion of 51% of houses is worked out as there is no mentioned about the total project outlay. Hence whether it is consistent with the G.R. issued by State cannot be ascertained nor it has been ascertained by Mumbai Board. 5. In the checklist at 3.1 the land is owned by whom is not given nor the 7/12 extract is given. 6. In annexure 7B the details about inspection carried by competent officer at Sr. No. 38 are not mentioned.
- 7. Land valuation report does not indicate whether it is committee report or not. 8. It is not clear how many units of 1 RK and 1BHK are proposed. 9. 1 RK carpet area is shown as 18.66 sqmt. whether this size is permissible under prevailing norms or not is not commented upon.10. Certified copy of ASR is not attached. 11. The plans, estimates submitted by the project proponent are not signed by board Officials, 12. Certified copy of DP sheet is not attached. 13. The undertaking which is submitted along with the DPR is neither signed by the implementing agency nor by the Chief Officer, Mumbai Board. It must be signed by both the officials.14. The scrutiny sheet indicates stilt + 33 Storied building but no. of units shown are 99 EWS + 4 LIG there seems to be some inconsistency.15. It is not clear from the proposal the total no. of houses being constructed under the project. Even it is not clear how many dwelling units are there from EWS and LIG houses. This needs clarity as the G.R. allows only EWS and LIG houses only under PMAY under PPP model. 16. Executive summary attached is not signed and it needs corrections. 17. The city profile is not attached with the DPR.18. The project cost mentioned in 7B needs correction.19. The sale price of the project is yet not approved by State. 20. Even the project must be a part of HFAPoA.21. The approach road width mentioned as 9 meter in annexure 7B and 18 meter in the noting. 22. It is not clear as how many units are proposed under ASR rate. 23. The built-up area shown is in-ordinately high.24. Water supply and land ownership documents not attached. The project was explained by the Executive Engineer, Mumbai Board Shri Dilip Garaje.
