 - 7. Original Manufacturer and/ or Dealers having experience of supplying equipments, materials required for testing Laboratory shall only quote their offer.
 - 8. Registration Certificate under GST is compulsory irrespective of Rs.20 Lakhs threshold limit.

- 9. The Bill has to be raised as per the formats provided by GST Invoice Rules.
- 10. The rates quoted should be inclusive of all taxes including GST.
- 11.TDS on GST will be deducted at the applicable rate from the date when it comes into effect.
