2. The Earnest Money Deposit will be in the form of Term Deposit Receipt of Nationalized/ Schedule Bank for a period of minimum 12 months duly endorsed in the name of Chief Accounts Officer, SPA Nagpur Housing & Area Development Board, Nagpur.
3. Blank tender form shall be issued only on production of original or photo sate copies (duly attested) of latest valid registration, PAN Card, GST certificate etc.
4. The tender amount is excluding GST. GST shall be paid by MHADA separately.
5. Joint-ventures are not acceptable for the work mentioned above.
6. Copy of Affidavit regarding completeness, correctness and truthfulness of documents submitted on Rs. 500/- Stamp Paper.
7. 2% of the amount put to tender should be remitted towards initial Security Deposit at the time of agreement.
8. All Contractors/Bidders (including Contractors registered with MHADA & PWD) shall submit Solvency certificate of amount of 20% of Estimated cost should be issued by nationalized bank/ scheduled bank put to tender in Technical bid.
