12. Permanent Earnest Money exemption certificate will not be accepted in lieu of Earnest Money Deposit.
13. Solvency Certificate of amount equivalent to 20% of estimated cost issued by Nationalized Bank/Scheduled Bank & shall be valid for period of one year.
14. Registration Certificate under GST is Compulsory Irrespective of Rs. 20 Lakhs threshold limit.
15. The bill has to be raised as per the formats provided by GST invoice rule.

16. The rates Quoted should be inclusive of all taxes including GST.
17. TDS on GST will be deducted at the applicable rate from the date when it comes into effect.
18. The contractor/ Agency should have experience of carrying out structural repair of RCC building in any two of the following modern technique and method.
  - Polymer chemical treatment.
  - Thixotropic mortars.
  - Jacketing .
  - Micro concreting.
  - Rebaring with Hilti technique.

The certificate issued by the Executive Engineer of the concern department or the bill of quantities certified by the competent authority or certificate issued by Architect in case if private work will have to be uploaded during bid submission reflecting any two above techniques clearly.
