 - b) Abstract of details of Technical Personnel on the rolls of the tenderer (information given in Statement No. 3.
 - c) Employee's State Insurance Corporation Certificate.All above original documents will be verified before acceptance of Tender. e-tender should submit information & scanned copies in pdf format in Technical Envelope as mentioned in Technical Offer.

In case of the rates quoted by lowest bidder less than estimated cost , & L1 bidder failed to submit Additional Performance Security Deposit within 8 days, then 2nd lowest L2 bidder will be asked to submit the revised offer and if L2's offer is at or below that of the rate quoted by L1 bidder offer of 2nd lowest (L2) will be accepted .
