- **1.6)** Interested Bidder has to be enrolled on e-Tendering system. As the Bid Data on the System is required to be encrypted and digitally signed online, Bidders are required to obtain Class-2 Digital signature certificate at the earliest.
- 1. 7) Pre-Bid Conference will be conducted by the C.E.-III.MHADA/ Dy. C.E./Konkan Board on dt. 04/10/2019 at 03.00 pm at Bharatratna Gulzarilal Nanda meeting hall, 3rd Floor, Griha Nirman Bhavan, Kalanagar, Bandra (E), Mumbai to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in of 'Instructions to Bidders' of the bidding document. The Tenderer may, in the forwarding letter, mention any points he may wish to make clear but right is reserved to reject the same of the whole of the tenders if the same become conditional tender thereby.
- 1. 8) The bid price for blank tender documents and other details is Rs. 3,000/ + 360/-(Inclusive of GST) = Rs. 3360/- (Rs. Three Thousand Three Hundred Sixty only) (Non refundable). Bid must be accompanied with scanned copies of Online Receipt for Tender form fee and Bid Security Deposit (BID SECURITY) from the above mentioned e-Tendering Portal of MHADA through Online Receipt System. Bid shall be treated as invalid if the above scanned copies are not submitted online along with the bid. - **1.10)** Solvency certificate of amount equivalent to 20% of the estimated cost should be issued by nationalized bank/ scheduled bank and shall be valid for period of one year and shall be considered for tender process, within its validity period.
- **1.11)** The successful bidder will be expected to complete the works by the intended completion date specified in the Contract data.
- **1.12**) Bidder shall have valid GST Registration Certificate, Permanent Account Number of Income Tax.
- **1.13)** The Agency shall have to give undertaking that they have not been black listed by any organization at the time of submission of tender.(on Rs.100/-Stamp paper)(Annexure IX, Page No I- 122)
- **1.14)** Bidder shall have at least 5years experience in Housing work.
- **1.15)** Age of organization shall not be less than 5 years.
- **1.16)** Right to reject any or all bids /offers without assigning any reason thereof is reserved by Competent Authority/MHADA.
- **1.17)** Conditional tender shall not be considered and shall be summarily rejected.
- **1.18)** The bidder shall have to produce original documents for verification, if called for.
- **1.19)** For all concrete works Fully Automatic Micro processor based PLC with SCADA Enabled Concrete Reversible Drum Type Concrete Mixer" of minimum 12 to 15 cum/hr capacity of any standard company with SCADA shall be install at site of work.
- 1.20) The contractor shall install Compression Testing Machine (CTM) for the testing cement mortar, concrete at the site, linked with "SCADA" etc. complete. The data so acquired shall be uploaded to MHADA Website or as directed in real time with time lag not more than 30 Seconds. In addition to that frequency of testing from govt. recognized lab has to be maintained as per Govt. / MHADA guidelines.
