- 11. Tender called is based on SSR rate year 2020-21 without GST. GST will be paid on accepted contract value.

In case of the rates quoted by lowest bidder less than estimated cost & L1 bidder failed to submit Additional Performance Security Deposit within 8 days, then Second lowest (L2) bidder will be asked to submit the revised offer and if L2's offer is at or below that of the rate quoted by L1 bidder then offer of 2nd Lowest bidder (L2) will be accepted.
- 13. As per the GR of PWD, Govt. of Maharashtra, there is a provision to allot upto Rs. 100 Lakh works to Labour Co-op societies in a year. If upto Rs. 100 Lakh works have been allotted to Labour Co-Op. societies in a year, then these Labour Co-op. societies will not be able to tender.
