1. A. If offer quoted is up to 10 % below Estimated Cost, then Agency shall submit **DD/FDR/BG** of 1 % of Estimated cost put to tender, towards **performance security** other than Security deposit mentioned in Tender notice. The **DD/FDR/BG** in original should be submitted in sealed envelope along with solvency and Bank conformation letter for both DD/FDR/BG as well as Solvency.
B. If offer quoted is more less than 10 % below Estimated Cost , then Agency shall submit Demand Draft of amount ; which shall be worked out as " (Quoted offer in % - 10 %) + 1 %) of Estimated cost put to tender. [For example, if, offer is 14 % below, then performance Security to be paid will be (14 % - 10 %) + 1 % i.e. Total 5 % of Estimated cost.]
2. Blank tender form shall be issued only on production of original or Photostat copies (duly attested) of latest valid registration, and certificate of previous experience of similar nature of Work done.
3. Earnest money, deposit shall be paid in the form of short terms deposit receipt for the period of the one year issued by the nationalised/schedule bank and endorsed in the name of Chief Accounts Officer / M.B.R.& R. Board, Mumbai.
4. The Blank Tender will be issued by the Executive Engineer GS Division., MBRR Board, 5th Floor, Near Mukhtangan School, Behind Vishwaraja Darshan bldg., Elphinstone(W), Mumbai - 400 013, and will be received in the same office. Sealed tender will be opened on the last date as per column No.8, if possible at 5.30 p.m. in the office of the Ex. Engineer, GS-Division, Prabhadevi (W).
5. All participating contractor shall submit the sealed Envelope on dated **23-02-2026, 11.00 a.m. to 02.30 p.m.** Sealed envelope submitting is compulsory. If they will not submit Sealed Envelope, Further action will be taken as per MHADA's Circular/Regulation and Govt. Regulation.
6. Bids from joint venture are not acceptable.
7. It is necessary that, a contractor shall have a Civil Engineer having minimum five-year experience similar type work and other supervising officer.
8. The experience of the sub-contractor and tools and plants owned by him will not be considered.
9. Kindy Read D.T.P copy before submitting Tender.
10. Right to reject any one or all tenders are reserved by the competent Authority.
