- **11.**Bidder shall have valid GST Registration Certificate, Permanent Account Number of Income Tax.
- **12.**The Agency shall have to give undertaking that they have not been black listed by any organization any time previously.(on Rs.500/- Stamp paper) (Annexure- IX)
- 13. Bidder shall have at least 7 years experience in Housing work.
- **14.** Age of organization shall not be less than 7 years.
- **15.**Right to reject any or all bids /offers without assigning any reason thereof is reserved by Competent Authority/MHADA.
- **16.**Conditional tender shall not be considered and shall be summarily rejected.
