CIRCULAR:

Subject :- Testing of building material used in construction works of MHADA to be carried out from Material Testing Laboratory MHADA only.

Reference :- Approval of Hon. Chief Engineer -I/A vide office Note No. DYCE/EE-I/VQC/A/11/2020, dt. 14/10/2020.

Material testing laboratory of MHADA is established for testing of various building material such as Cement, Sand, Bricks, Metal, Steel, C.C. Cubes, Autoclaved Cellular Concrete Block, Tiles, Pavor Blocks, etc. used in construction works from various Boards/Divisions.

Previously vide circular No. Dy.CE/EE-1/VQC/A/408/2018 dt. 03.04.2018 permission was given to contractors to carryout test of their site works materials from 8 other laboratories other than MTL/MHADA.

Now all the lab procedures other than actual testing of material is computerized in march 2019, lab is ISO 9001:2015 certified on 21.01.2020, and recently lab is renewed, and lab is having full strength staff to carry out testing of material.

Due to covid -19 pandemic situation work quantum of all the Boards is reduced and in this situation some of the agencies are still carrying out testing of material from outside laboratories due to which there is revenue loss to MHADA. To overcome this revenue loss all concerned are hereby informed that the testing of building material should be carried out from MTL/MHADA only, till further orders.

However the frequency for testing of building materials from MHADA lab has to be maintained as per the tender condition of respective work.
